

## **Best Execution – Top 5 Execution Venues 2017**

Implementation of the Markets in Financial Instruments Directive (MiFID 2) has obliged firms to publish a list of top 5 venues used by an investment firm for client order execution.

BCS Prime Brokerage Limited (“BCS UK”) executes orders in the following instrument types:

- 1) Equities
- 2) Debt Instruments (Bonds)
- 3) Futures
- 4) Options

BCS UK shall publish the top execution venues in terms of trading volumes for all executed client orders per applicable class of financial instruments referred to in Annex 1 of the regulation.

As BCS UK does not facilitate transactions for retail clients, the information regarding retail clients is not included in this report.

The information is published, in accordance with the requirements as set out in Article 3 and Annex 2 of the regulation.

The reports display the following details (where applicable):

- (a) class of financial instruments;
- (b) venue name and identifier;
- (c) volume of client orders executed on that execution venue expressed as a percentage of total executed volume;

(d) number of client orders executed on that execution venue expressed as a percentage of total executed orders;

(e) percentage of the executed orders referred to in point

(d) that were passive and aggressive orders;

(f) percentage of orders referred to in point

(d) that were directed orders;

(g) confirmation of whether it has executed an average of less than one trade per business day in the previous year in that class of financial instruments.

ESMA appreciates that due to novelty of the report, the first set of reports published by investment firms may lack some specific details, tied to new provisions of MiFID 2, for the preceding year.

This means that BCS Prime Brokerage Ltd. was not able to provide all necessary granularity on each of the Execution Venues, such as,

- Percentage of Passive Orders
- Percentage of Aggressive Orders
- Percentage of Directed Orders
